Cheques should be made payable to “Massachusetts Bay League”. We also accept purchase orders, provided that the dues and fees are paid within 90 days.

Community Boating Fees:

\$55 per student sailor per season, plus
\$250 per team for the Spring season or \$150 for the Fall season

All CBI-fees are payable to “Community Boating, Inc.” and are due prior to the commencement of sailing. CBI will also accept a purchase order form the school.

Policy of Dues Payments

Participation in the Massachusetts Bay League is contingent upon each team paying its dues and associated fees for the current sailing season as well as any prior season(s).

For the Spring Season:

1. Dues and fees should be paid by April 1. Purchase orders shall be accepted in lieu of payment in full.
2. For purchase orders, payment in full is due within 90 days of the issue of the purchase order. After the 90 day period, a late fee of \$100 will be assessed.
3. After April 15, member schools will be able to register or compete in any MBL-affiliated event only if they have paid their dues or submitted a purchase order.
4. After April 15, a late fee of \$50 will be assessed on member schools that have not paid their dues or submitted a purchase order for those dues.
5. After May 15, an additional late fee of \$50 will be assessed on member schools that have not paid their dues or submitted a purchase order for those dues.
6. After May 15, all race results counted as forfeits (for the purpose of League standings and awards) for any member school that has failed to pay their dues or submit a purchase order for those dues.
7. Upon receipt of overdue dues and any applicable late fees, member schools will be allowed to register and compete in MBL-affiliated events providing that payment is received at least five calendar days prior to the event and the event is not fully subscribed at that time.
8. Failure to pay dues for more than 12 months shall be grounds for the officers of the League to rescind membership in the League for such schools. Notice of such action shall be communicated in writing to the Athletic Director of the school.

For the Fall Season:

1. Dues and fees should be paid by September 15. Purchase orders shall be accepted in lieu of payment in full.
2. For purchase orders, payment in full is due within 90 days of the issue of the purchase order. After the 90 day period, a late fee of \$25 will be assessed.
3. After October 15, a late fee of \$25 will be assessed on member schools that have not paid their dues or submitted a purchase order for those dues .
4. Failure to pay dues for more than 12 months shall be grounds for the officers of the League to rescind membership in the League for such schools. Notice of such action shall be communicated in writing to the Athletic Director of the school.

This policy shall be enforced beginning with the Spring 2012 season and shall not consider any unpaid dues or fees prior to January 1, 2010.
